## **OFFICIAL GIVEAWAY RULES**

## NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility. This giveaway is open only to legal residents of the 50 United States and the District of Columbia who are at least 18 years old at the time of entry.
